



In particular, the **Department of the Interior** continues to push forward on major public land policy changes, changes to regulations, oil and gas lease sales and related public comment periods, for the following:

- U.S. Fish and Wildlife Service Take of Migratory Birds that proposes to redefine the scope of the Migratory Treaty Bird Act
- Bureau of Land Management SEISs for Greater Sage Grouse
- Bureau of Land Management Draft Farmington Resource Management Plan and Environmental Impact Statement
- California Desert District Advisory Council Field Trips
- Draft Resource Management Plan Amendment for Draft Environmental Impact Statement for Wild Horse Management, BLM Wyoming field offices
- Categorical Exclusion for Pinyon Pine-Juniper Removal
